This strategic agreement allows AMTEGA and the Galician public sector to provide facilitated access to public cloud services, innovation programs, and training, ensuring consistent, secure, and proactive cloud usage. Furthermore, Eviden will provide advisory and incidental support through its resources and partners, promoting success stories to drive AMTEGA's transformation goals.

The framework agreement will generate various benefits, with four particularly highlighted.
