¹ The NIS2 Directive (Network and Information Security 2 Directive) is an updated version of the European Union's NIS Directive, which aims to strengthen the cybersecurity framework across EU member states.

² The Hospital Future Act (KHZG) is the government-funded "digital update" for the hospital landscape. The investment program of 4.3 billion euros is intended to modernize the digital infrastructure of hospitals.
