- **Citizen eID documents**, for securing official documents issued by the French government, such as biometric passports, European residence permits and electronic national identity cards (CNIe), as well as the application infrastructure within town halls and prefectures.
- **French security standards RGS (* and ***) and eIDAS** qualified digital identities, used in particular on agent cards, supporting secure access through strong authentication and qualified signatures.

This highly secure system is based on Eviden's cutting-edge cryptography technologies, in particular Eviden's Proteccio sovereign security module (HSM), currently the only one on the market to be certified "Qualification Renforcée" by ANSSI. This level of certification guarantees increased resistance to attacks and compliance with the most stringent regulatory requirements, offering the government unparalleled levels of trust and resilience.

As a strategic partner of the French government, Eviden has been supporting France Titres since 2006 in digital identity security, thanks to its cybersecurity products and, in particular, its sovereign digital identity solutions IDnomic.
